<u>FEES</u>: A \$15.00 fee applies to change ownership of a pet listed with Central Animal Records. Payment must accompany this form, & can be made by cheque or money order, made out to *Central Animal Records*, or by completion of credit card details (see below). Once processed, an Identification Acknowledgement reflecting these changes will be issued to the new owner. If the previous owner/s has not signed this form, the transfer could take up to 23 days as we are legally required to contact the previous owner/s for consent to transfer ownership.
